IOTICE IS HEREBY GIVEN that a Special Municipal lection will be held in the City of Richmond on leady, November 6, 2012, at which there will be ubmitted to the voters the following measures:

"Shall an ordinance be adopted to impose a busi-ness license fee of one (1) cent per ounce of sugar-sweetened beverage served, provided, or traded by businesses in the City?"

ADVISORY VOTE ONLY: "Should the proceeds of any business license fee measured by the serving, providing, or trading of sugar-sweetened beverages be used: to have more after school sports programs, to make them less expensive and to provide neathlier school meals, n u t r it it o n classes and cooking classes; to provide medical care for children with diabetes who can't afford are; and to support other worthy projects to prevent and treat diabetes and childhood obesity?"

ADVISORY VOTE ONLY: "Should Richmond's congressional representatives be instructed to propose, and Richmond's state legislators instructed to ratify, an amendment to the United States Constitution to provide that corporations are not entitled to the Constitutional rights of real people, and that there should be limits on all spending in political campaigns, including ballot measures and "independent expenditures?"
